It is contended by learned counsel for the petitioner that enlistment/registration applications of petitioner are pending before respondent No.3. Further submits that he would be satisfied that if a direction is issued to respondent No.3 to decide the pending applications strictly in accordance with law at the earliest and till then, no coercive measures may be taken against the petitioner. Learned counsel further submits that already an identical matter bearing Writ Petition No.62179 of 2022 has been dealt with by this Court, therefore, the same relief may kindly be granted to the petitioner.

2. When confronted, learned law officer, appearing on Court's call, has expressed no objection on disposal of this petition as requested by learned counsel for the petitioner.

3. In view of above, I am inclined to direct respondent No.3 to decide the pending applications of the petitioner strictly in accordance with law, after hearing the petitioner and all concerned, through a speaking order, within a period of thirty days from the date of receipt of certified copy of this order, under intimation to the Deputy Registration (judicial) of this Court and till then, no adverse action shall be taken against the petitioner.

4. Instant petition stands disposed of accordingly.

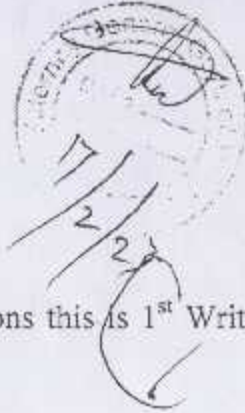
