2. Following instructions/ conditions are also prescribed.

- a) Initial stock taking shall be conducted in supervision of a senior officer. Report in this regard will mandatorily be shared with Board.
- b) Weigh Bridge daily inward/ outward record along with copy of documents generated shall be obtained and retained;
- c) Daily fuel to clinker/ cement production ratio shall be determined on daily basis and reported to the Board.
- d) In case of beverages concentrate, daily monitoring of consumption of concentrate shall be monitored for bottlers and daily production and dispatch of concentrate for manufacturers and accordingly reported.
- e) The CCIR, having jurisdiction over the above cases, may make vigilance teams etc, to ensure that no lapse occurs in duty by the posted staff.

3. The officials/ officers are posted for a period of 30 days commencing from date of receipt of order u/s 40B of the Sales Tax Act, 1990. A comprehensive report on outcome of the monitoring u/s 40B (ibid) may be furnished to the Board on the culmination of this exercise.
